# Counsel's Fees Scale (excluding GST)

The Registrar of the Supreme Court has indicated that, upon taxation of party and party costs, the following scale of fees may be expected to be allowed where briefs are delivered, matters heard or conferences are held on or after **5 July 2021**.

Where only one figure is set out, it may be interpreted as the expected minimum. However, it must be realized that the Taxing Officer still has a discretion to allow a higher or lower fee than is set out herein.

It should be noted that the fees set out below do not necessarily reflect the fees which barristers actually charge. Some barristers will charge less, others will charge more. Market forces will dictate fees. The scale will be used by the taxing officers of the Court as a guide to determine how much, by way of costs, a successful party may expect to recover.
