

Foreword from Amanda Nuttall, Principal Registrar and CEO

The Disability Justice Strategy 2019–2029 provides justice agencies with a framework, highlighting where we can consider making improvements to deliver inclusive services and practices.

This action & inclusion plan shows how the ACT Courts and Tribunal (ACTCT) will improve our inclusive practice.



The ACTCT already has a range of services to assist people with a disability, including a court and tribunal assistance officer, pre-hearing tours of our facilities, access to the National Relay Service, Auslan interpreters, hearing loops, options for transcripts, assistance animals and modified security screening. This action & inclusion plan is about taking us beyond the services we already have, listening to feedback and making improvements to assist people with a disability to access our services.

We understand the need for our staff to learn about the needs of our diverse community and facilitate a range of supports for those who face barriers or challenges in accessing justice services.

Our staff need to be competent in identifying opportunities for improvement, what reasonable adjustments are available and when they need to be considered. In 2022, we will be rolling out awareness training through an e-learning module to our staff, that will develop our organisational competency in the area of disabilities and inclusion.



In recent years the ACTCT has come a long way as an organisation.

In 2019 the new ACT Law Courts building opened, providing the opportunity to deliver state of the art modern facilities. The new building has allowed the ACTCT to identify and address a range of physical barriers and implement technological supports to assist people with disability. In 2022 the ACAT will also

move into new premises, which will focus our attention on the facilities at the Tribunal. New facilities have provided the organisation with a new platform on which to build our inclusion foundations.

In 2019, the ACT Courts and Tribunal developed a partnership with Guide Dogs NSW/ACT to deliver a canine therapy support program. The program sees a therapy dog visit the court a few hours per week supporting vulnerable persons at court such as children and victims, many of whom are anxious about being at Court.

In mid-2021 the ACTCT recruited a Disability Liaison Officer (DLO) for 18 months as an initiative under the Disability Justice Strategy. The role of the DLO is our conduit to developing partnerships with the



community sector and with other government agencies. This new role informs our Executive team about what actions we can implement to improve inclusion.

The ACTCT is also working in partnership with other organisations to develop a community of practice. The ACTCT has had long standing relationships with ACT Government mental health and drug and alcohol services in the ACT. Our collaborative practice to support persons with a disability across the justice system continues to develop via our engagement and meetings.



I am pleased to report that in 2021 we have commenced improving the way we provide information to the ACT community. This includes new videos explaining what assistance is available within our Courts and Tribunal and developing materials in easy English.

New initiatives will include a needs assessment tool, community of practice, e-learning module for staff and improvements to the way we deliver and communicate information.
