Grounds of Application

The orders are sought on the following grounds:

- 1. On 28 September 2023, Registrar Reece of the ACT Supreme Court ordered, inter alia, by orders 3(a) and 3(b) of the orders entered on that day that:
 - a. by 13 October 2023, the parties exchange categories of discovery, identifying with specificity that fact in issue to which each proposed category is relevant; and
 - b. by 20 October 2023, each party from whom discovery is sought is to notify the requesting party which of the proposed categories are agreed and which are not agreed and a short explanation for the reason for the disagreement.
- 2. In complying with the orders entered on 28 September 2023, the plaintiff and first defendant have agreed on categories of documents for the first Defendant to discover, save for Categories 4 and 9.
- 3. By Order 3(c) of the orders entered by Registrar Reece on 28 September 2023, 'The matter is to be relisted for hearing to determine any disputed discovery categories on a date to be fixed'. In compliance with Order 3(c), the plaintiff brings this Application in Proceeding, so as to have Categories 4 and 9 determined.
